- (a) **Disclosure Category 1**. Persons in this category shall disclose income (including gifts) from any source, interests in real property, investments, and all business positions in which the designated employee is a director, officer, partner, trustee, employee, or holds any position of management."
- (b) **Disclosure Category 2.** Persons in this category shall disclose all sources of income, investments, and all business positions in which the designated employee is a director, officer, partner, trustee, employee, or holds any position of management.
- (c) **Disclosure Category 3.** Persons in this category shall disclose all income from and investments in business that manufacture or sell supplies of the type utilized by the Successor Agency.
- (d) **Disclosure Category 4.** Persons in this category shall disclose all investments in and income from all banks, savings and loan associations, insurance companies, investment companies, stockbrokers, title companies, financial consultants, data processing firms or consultants, but shall not include personal checking or savings account or certificates of deposit.
- (e) **Disclosure Category 5.** Persons in this category are consultants who meet the standards for a consultant promulgated by the California Fair Political Practices Commission and such consultants shall disclose all sources of income, interests in real property and investments.
