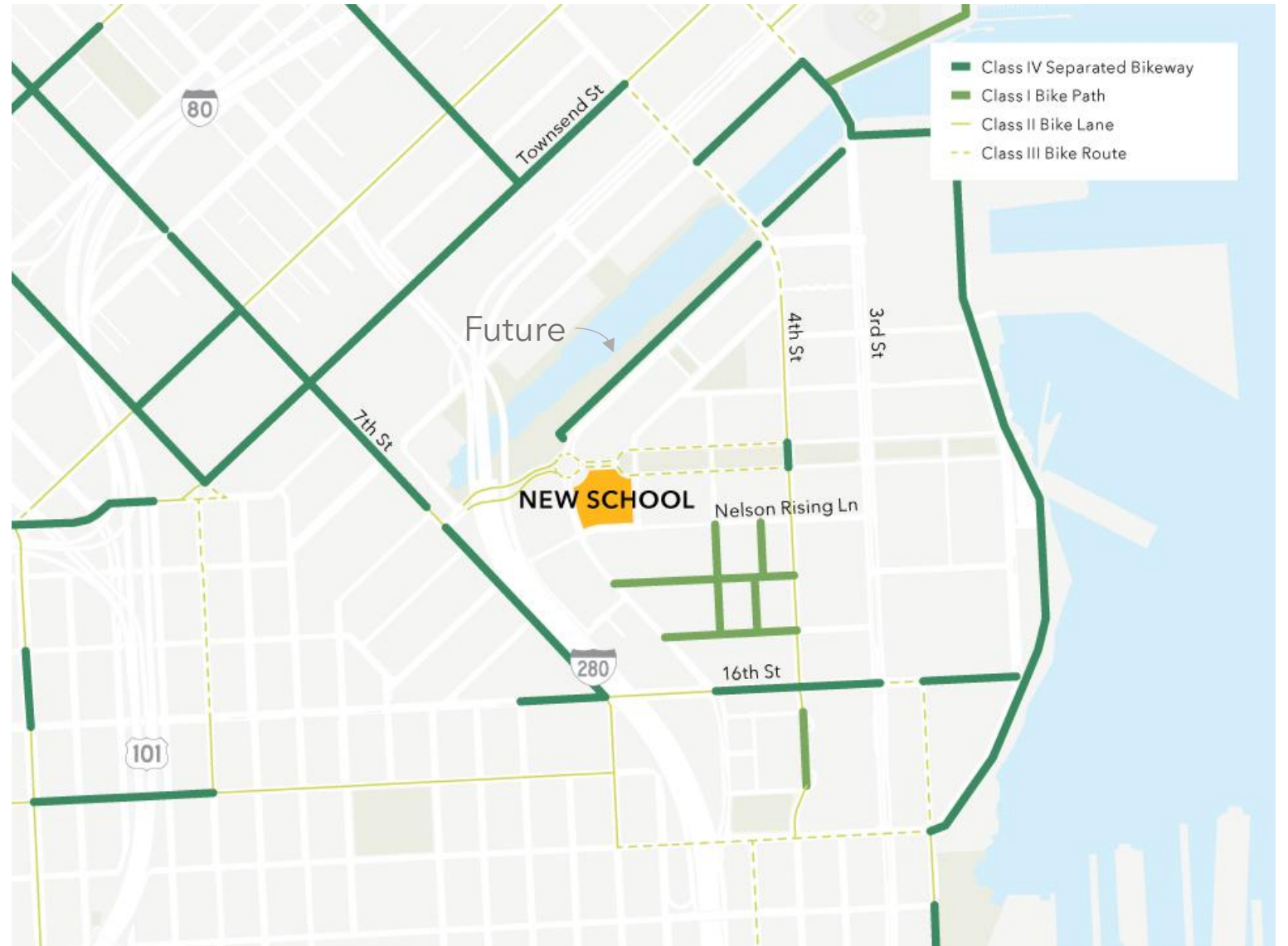
Core Scope

- Identify road segments which need improvements to connect the school site to SF’s Broader active network



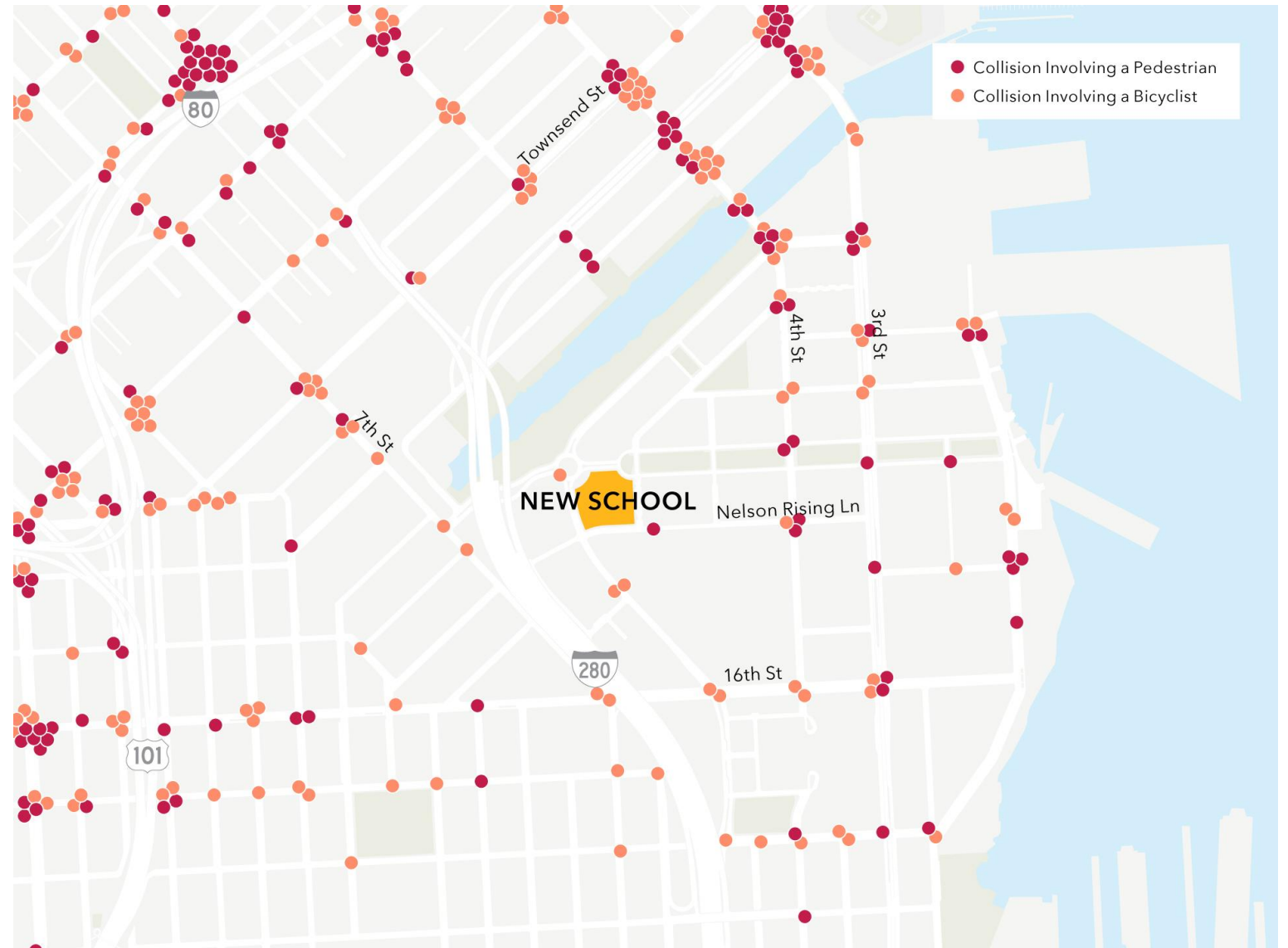
Connecting to Sustainable Transportation

The Mission Bay School Access Plan will ensure school site is well connected to San Francisco's active transportation network and nearby transit



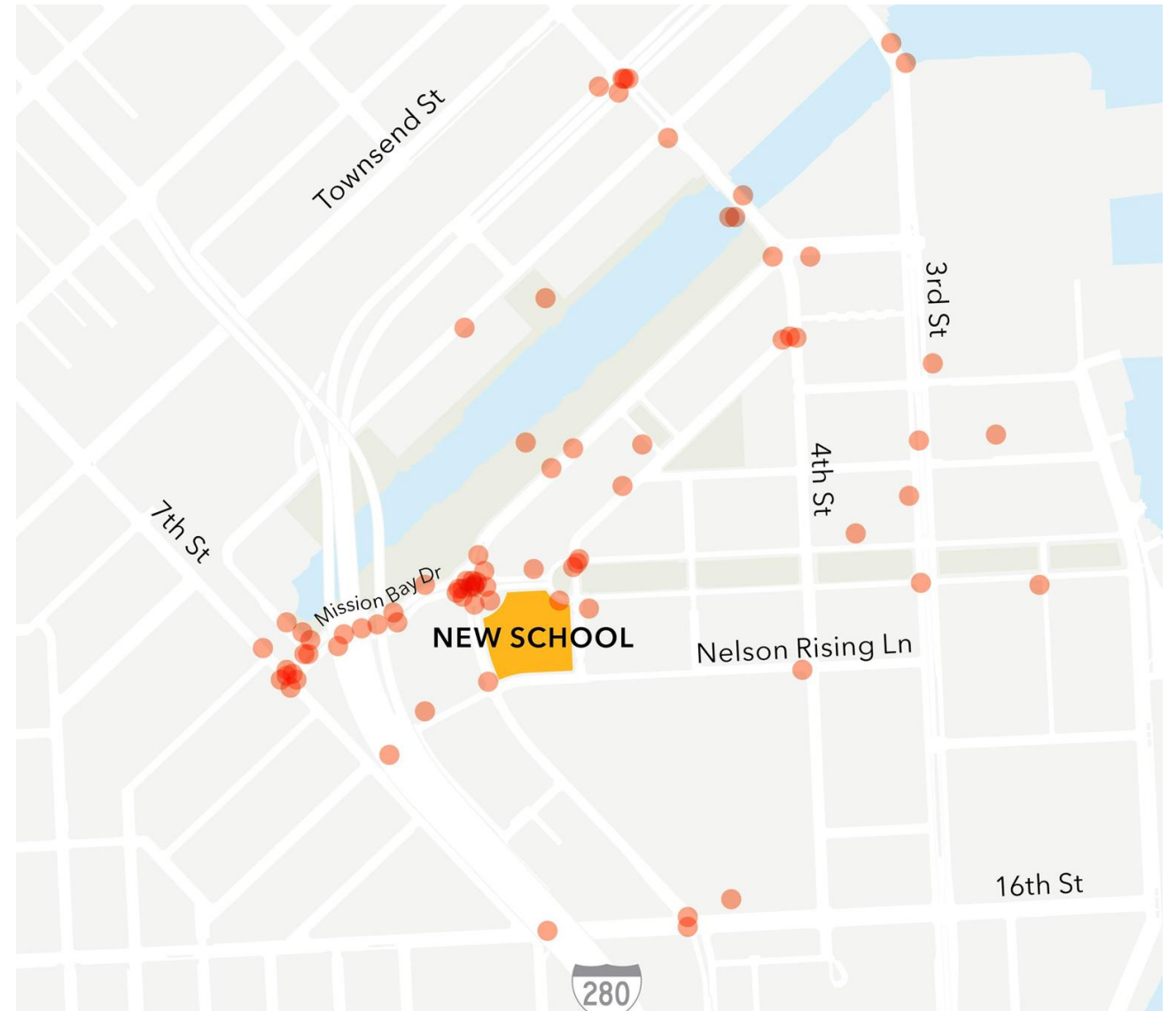
Make Connections Safe for All Ages and Abilities

Ensure connections to the school site are safe for people riding and walking of all ages and abilities

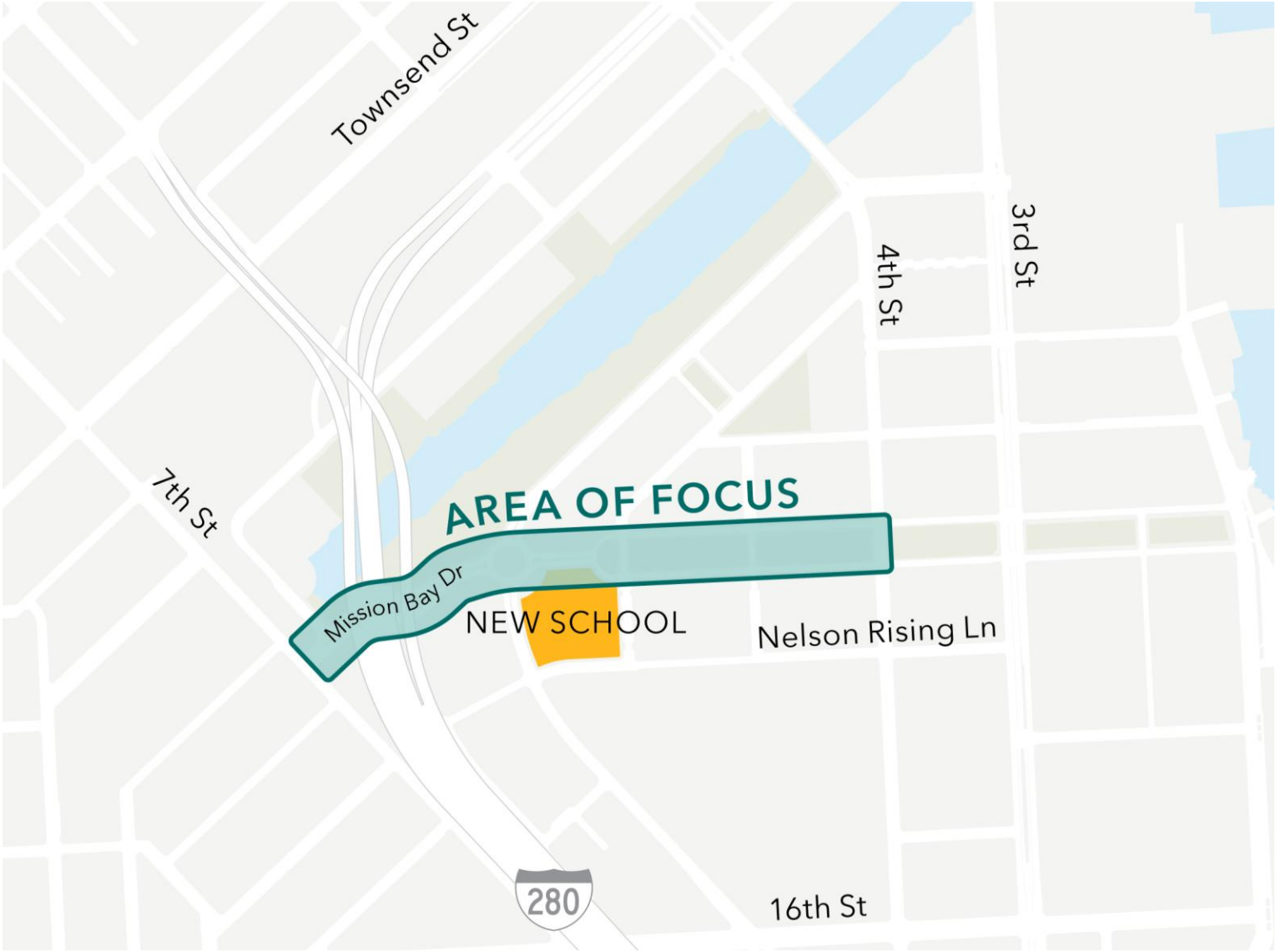

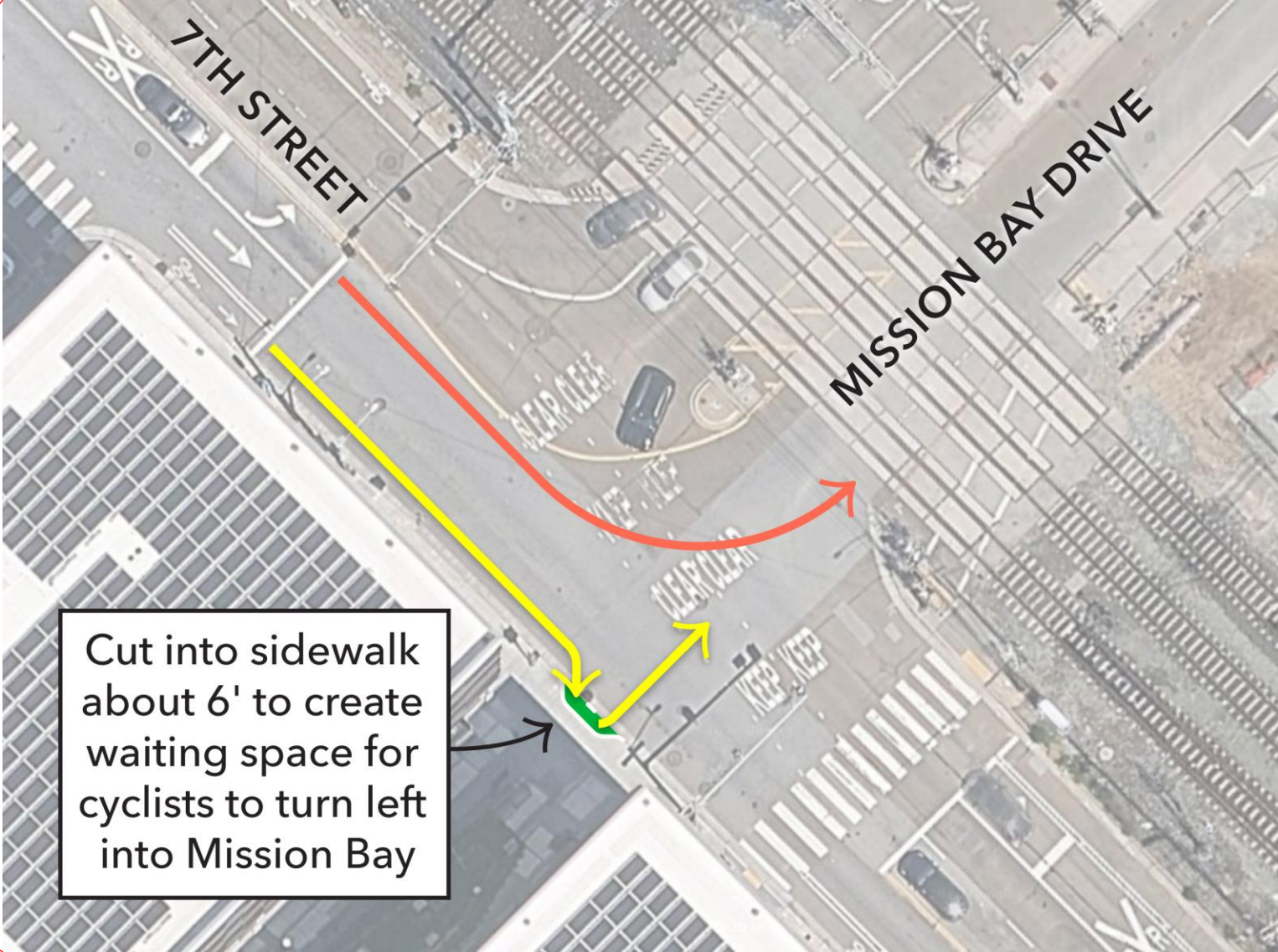
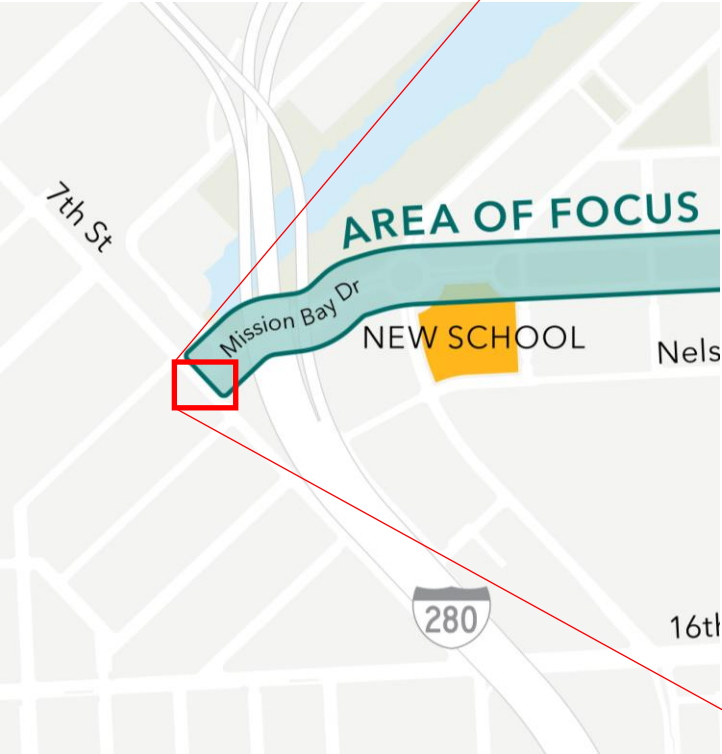

Jughandle on 7th Street



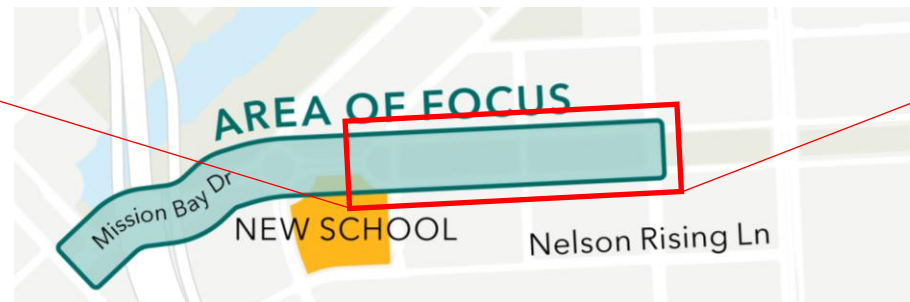
Jughandle on 7th Street

Example: Market at Valencia

- Creates a safe space for people biking to wait and cross with signal
- Eliminates the need to merge across through-traffic and queue with drivers



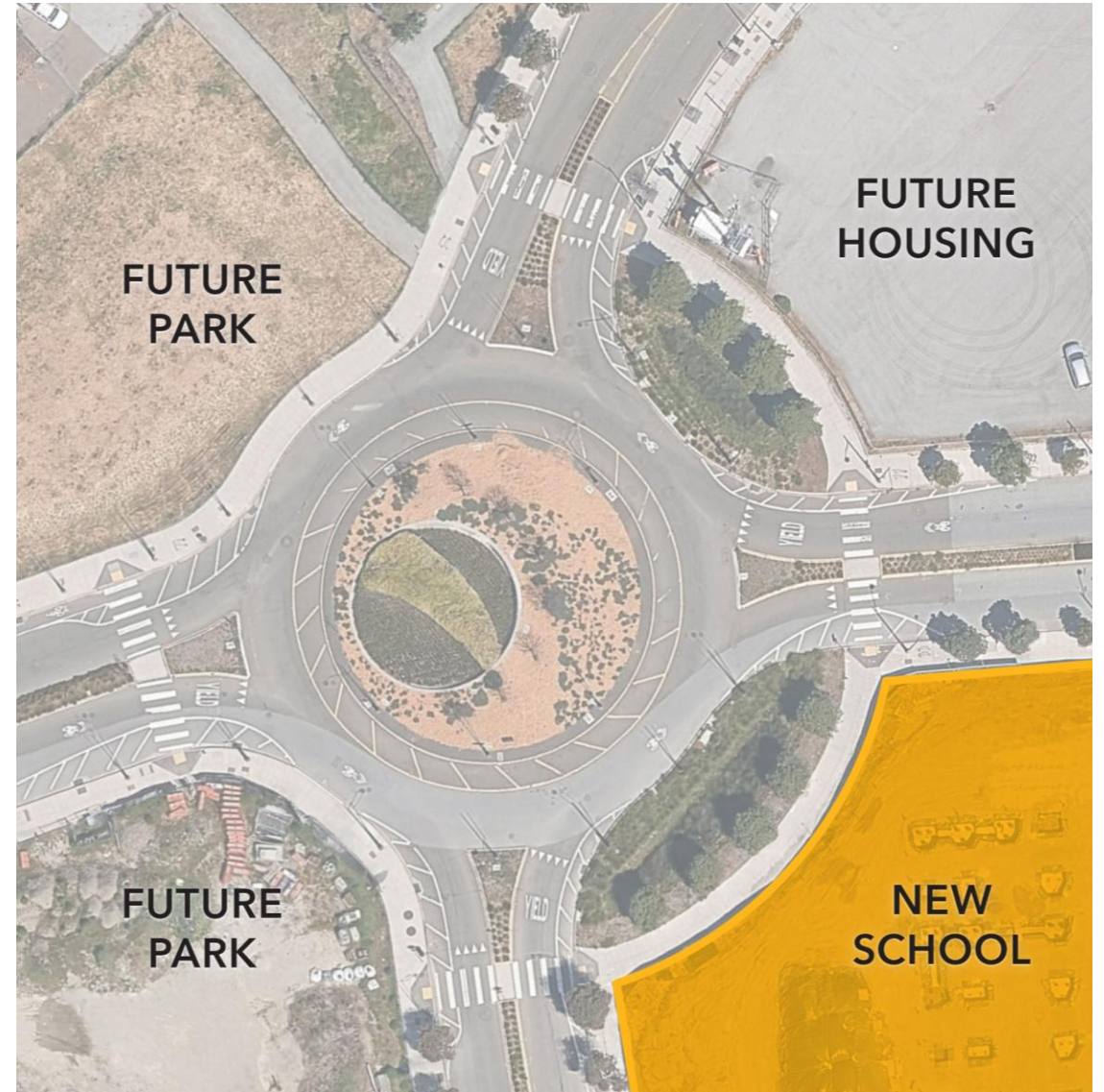
Mission Bay Boulevard Traffic Calming



Preliminary Roundabout Alternatives

Developed and evaluated three alternatives then shared for feedback

- Alt A - Convert existing sidewalk into sidewalk plus bikeway
- Alt B - Build new sidewalk, convert existing sidewalk to bike path
- Alt C - Protected bike path within roadway



Feedback we heard

- Strong support for traffic calming Mission Bay Boulevard and bike access improvements at 7th Street.
- Desire for additional pedestrian improvements in roundabout designs
- Desire for additional improvements at 7th / Mission Bay intersection

Response to that Feedback

- Deliver Mission Bay Traffic Calming on accelerated schedule for school opening.
 - Additional community walk; Implementation underway.
- Began an exploration of signal infrastructure and timing changes at 7th/ Berry/ Mission Bay Drive
- Developed two new roundabout alternatives and a revised draft recommendation for the roundabout

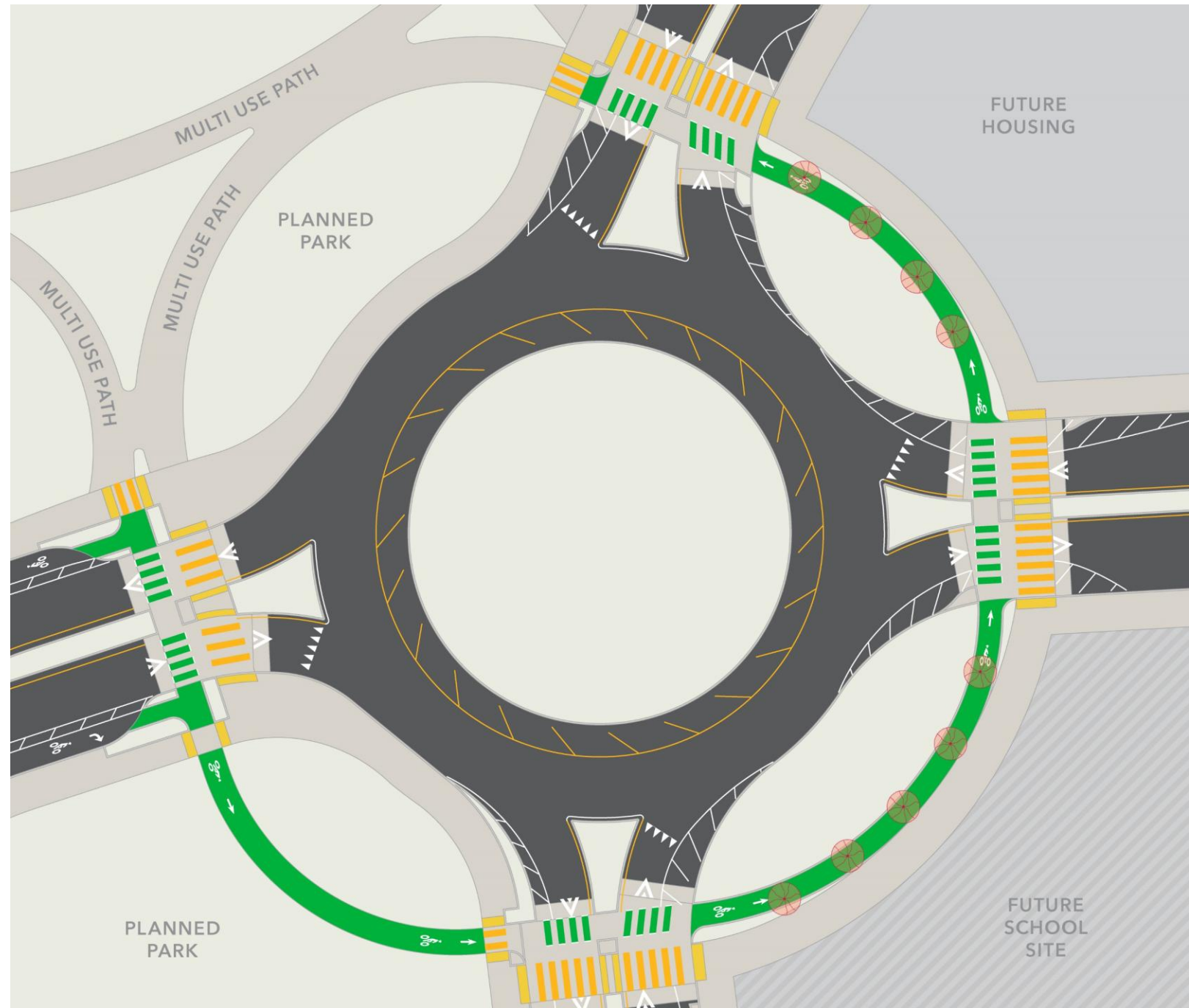


Both New Alternatives Include

- Maintaining extra wide sidewalk (14')
- Robust Raised crossings where bikes and peds cross roadway
- Separated one-directional path for cyclists (8')

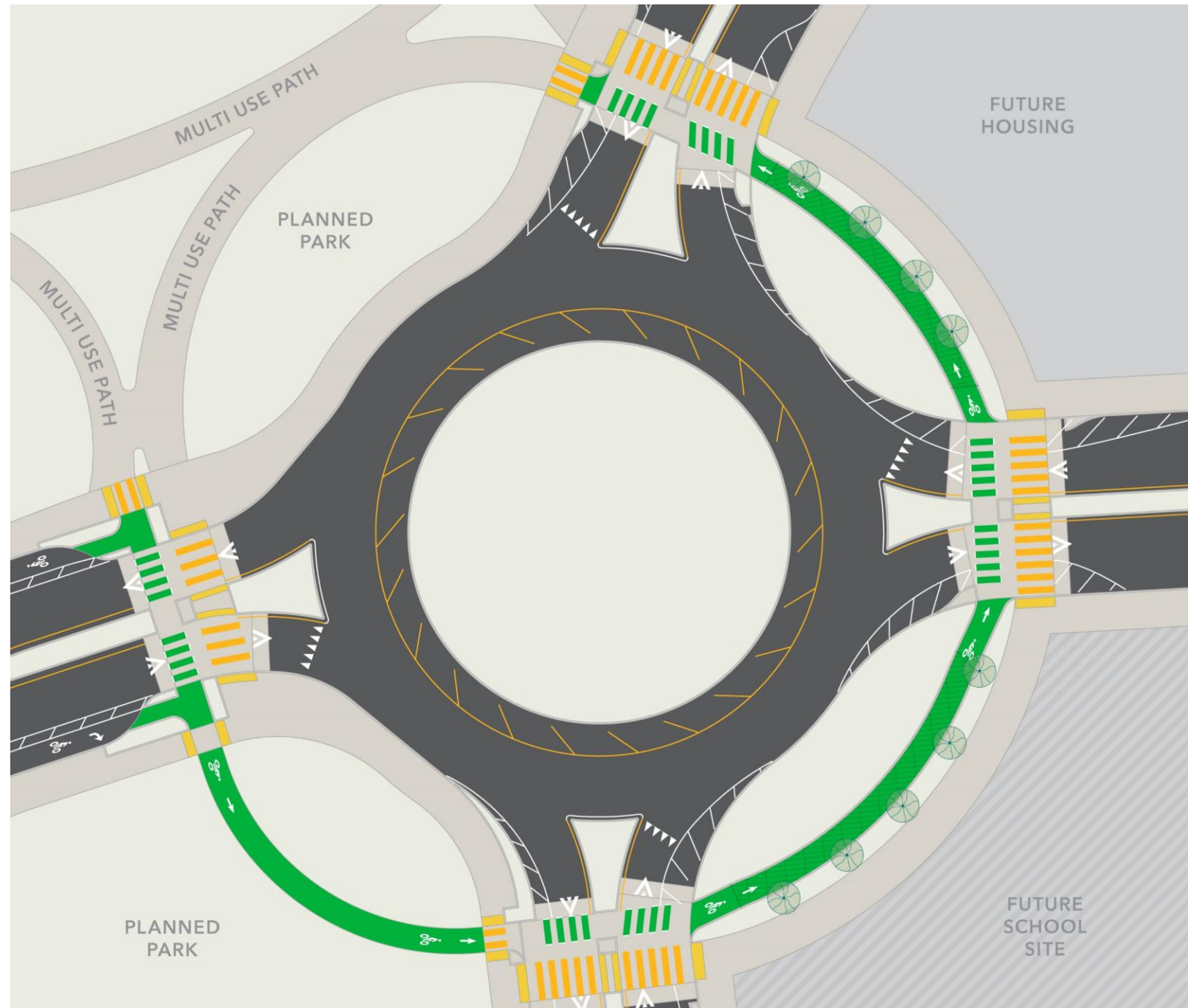
New Roundabout Alternative: **Bike Path Adjacent Sidewalk**

- Cyclists routed adjacent sidewalk on asphalt path supported by retaining wall
- Requires removal of nine trees
- \$3 - 4M



New Roundabout Alternative: **Boardwalk**

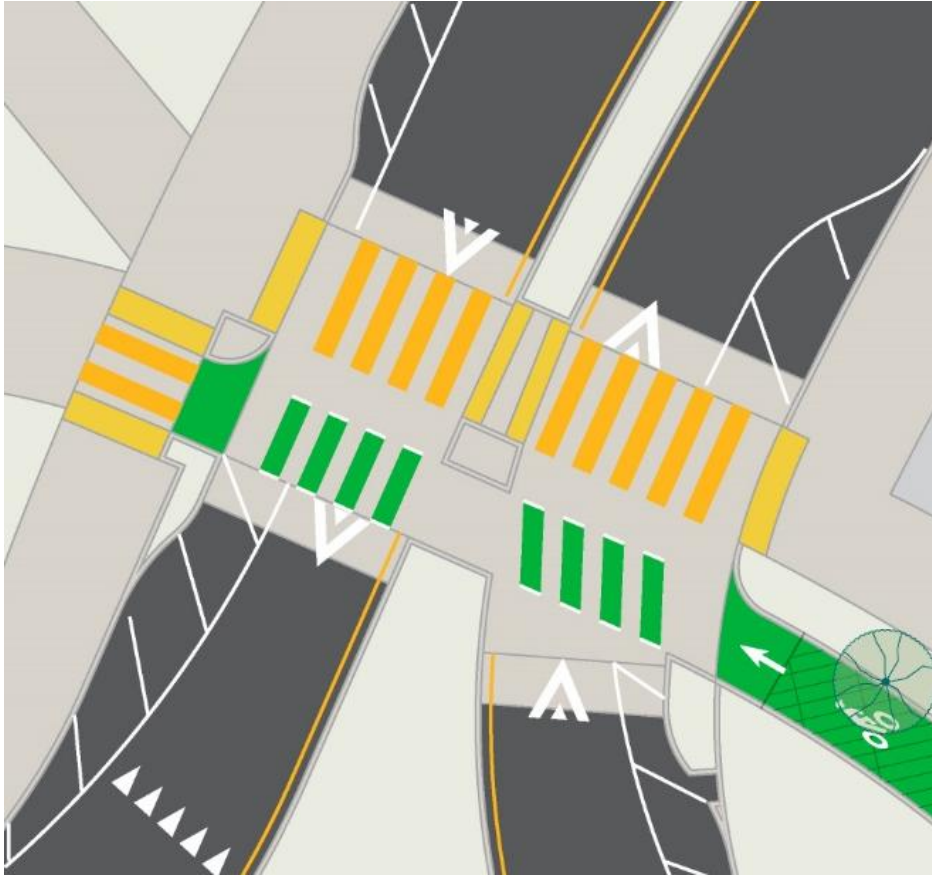
- Concrete poured in casts
- Some novelty risk
- \$2.5 - 3.5M



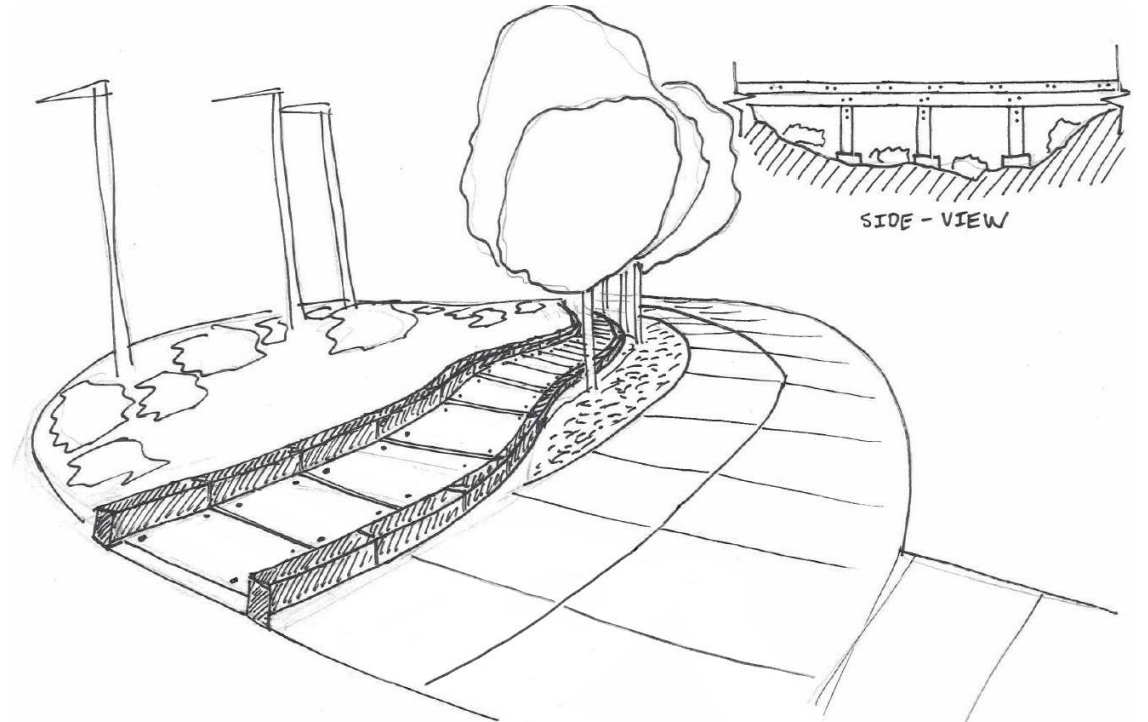

Elevated Crossings



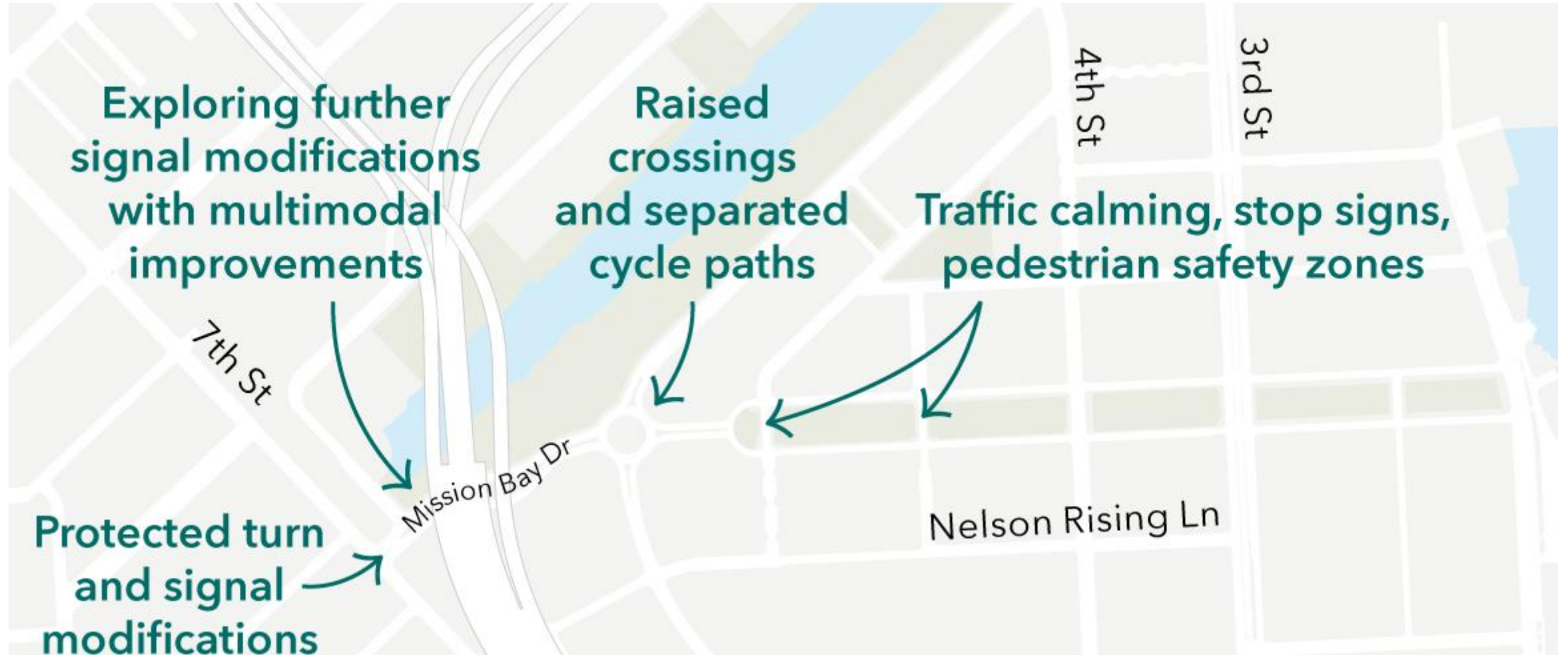
Separated bikeway
