Q&A Highlights

- Public events will not require pre-registration; if it does, a neighborhood access code will be provided for local residents to gain entry.
- No fireworks are proposed.
- For all sidewalk closures, security personnel and guest services staff will be present to provide additional information and detour directions.
- A map detailing all closures and detour routes will be available at chasecenter.com.
- Bridges and local neighborhood streets, including Bridgeview Way, will have parking control officers on site. Residential and commercial access will not be impacted.
- Attendance will vary by event, with approximately 2,000 attendees expected for the Tip-Off event, 12,000 for the Rising Stars event on Friday, and 15,000 for the All-Star games on Saturday and Sunday.
- Additional non-NBA sponsored private events may be held throughout the City.

Q&A Highlights

- The Bike and Rolling Plan is a citywide plan; individual projects, including the Mission Bay Circle, will be further studied as separate projects.
- Regarding coordination with SFCTA's Mission Bay School Access Plan, each SFUSD school independently manages student drop-off and pick-up. Once staff are assigned to the Mission Bay School, SFMTA, SFCTA, and other stakeholders will coordinate directly with school staff.
- Community input and coordination are encouraged in areas that require further study.
- Community members requested additional signage is recommended to encourage scooter and bike users to utilize designated pathways and bike lanes rather than sidewalks, which SFPD enforces against. The CAC Chair suggested raising this issue with SFPD staff during their next update to the CAC.
