Item 2: Discussion/Action Item: Bayfront Park Temporary Art Installation (Waterfront Walk Initiative) – 10 minutes

<u>Description of Item:</u> In Spring 2025, the Port received an unsolicited proposal from the Sijbrandij Foundation and Building 180 to install up to 20 temporary large-scale sculptures by emerging artists. The first phase, planned for Fall 2025 and Summer 2026, will feature installations along the Central and Northern Waterfront, including Bayfront Park, as the start of the large-scale Waterfront Walk initiative. Item 3: Discussion/Action Item: Approval of a Secondary Use Designation for an Animal Care use on Block 5 (1200 Fourth Street) – 15 minutes

<u>Description of Item:</u> Sunshine Dogs Club, a dog grooming and dog daycare with overnight boarding business, is proposing to occupy approximately 2,495 sq. ft. of ground-floor retail space at Mission Bay South Block 5 (MB360 Apartments). Approval of this use requires a Secondary Use Determination from OCII per the Mission Bay South Redevelopment Plan. This is an action item – the MBCAC will vote.

- The previous tenant, Healthy Spot, closed its Mission Bay Location
- Animal liquid waste will be disposed of through the sanitary sewer system. All other items will discarded through regular trash service.
- Sound mitigation measures, including sound-absorbing material, will be incorporated into the build out as well as non-porous cleanable finishes.
- Projected opening is anticipated in early 2026.

Storm Water Pump Station #3

Questions and Discussion:

- Construction is anticipated to be a two-year duration beginning in mid-Sept 2025.
- The pump equipment lead time is one year from order to arrival of the equipment.
- A more detailed schedule from the contractor is expected by end of the month.
- The majority of the facilities (pumps and wells) are underground with access panels above ground.
- The details of the traffic control plan are working with MTA, however, expect significant challenges and closures when the pumps are installed.
- There will be some work that will occur at night due to requirements for the adjacent MUNI T- rail line.
- Loud pile driving is expected for 2 weeks, community will be notified in advance.
- Trees will be removed and replaced with additional trees. Tree applications submitted to BUF.
- Upon completion, PUC manages below-ground work; RPD manages above-ground improvements. Pumps are checked annually by PUC (one week of work).
- The construction will be timed with Giants and Chase Center events, workers must be off roadways two hours before and after events. All other City restrictions apply for working limits
