Description of Item: American Bridge Company, the contractor selected for Phase 2 of the Third Street Bridge Rehabilitation project has identified dates in the coming months where preliminary assessment, mobilization, and the start of rehabilitation work may impact vehicular, pedestrian, bicycle and water craft circulation on/under the bridge. Thomas Roitman from the San Francisco Department of Public Works will provide an update on the project schedule and impacts.
